ORDINANCE NO. _____

AN ORDINANCE AMENDING THE TRAFFIC ORDINANCES OF THE CITY OF MARSHALL, MISSOURI, BY PROHIBITING PARKING ON CERTAIN PORTIONS OF CERTAIN CITY STREETS

WHEREAS, the City of Marshall, Missouri (“City”) has determined that it is beneficial to prohibit parking on certain portions of certain City streets as more fully set forth below.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Marshall, Missouri, as follows:

Section 1. The City’s traffic ordinances shall be amended as follows:

- a.** The parking of vehicles on the east side of Salt Pond Avenue from Arrow Street to College Street shall be prohibited.
- b.** The parking of vehicles on the west side of Miami Avenue from Arrow Street to Vest Street shall be prohibited.
- c.** The parking of vehicles on the west side of English Avenue from Arrow Street to Vest Street shall be prohibited.
- d.** The parking of vehicles on the south side of High Street from Miami Avenue to English Avenue shall be prohibited.
- e.** The parking of vehicles on the south side of Hanie Street from English Avenue to Jefferson Avenue and on the north side of Hanie Street from English Avenue to a point one hundred fifty feet (150’) east of English Avenue shall be prohibited.
- f.** The parking of vehicles on the south side of Ohio Street from English Avenue to Lafayette Avenue and on the north side of Ohio Street from English Avenue to a point one hundred fifty feet (150’) east of English Avenue shall be prohibited.

Section 2. The City shall place and maintain signs giving notice of this amendment to the City’s traffic ordinances and this ordinance shall not be effective unless such signs are in place.

Section 3. All other ordinances or parts of ordinances in conflict herewith are hereby repealed. In all other respects, the Code of Ordinances of the City of Marshall, Missouri shall remain unchanged.

Section 4. This Ordinance shall be in full force and effect from and after its passage and approval.

ORDINANCE NO. _____

AN ORDINANCE PROVIDING FOR A GENERAL MUNICIPAL ELECTION TO BE HELD ON APRIL 4, 2023, IN THE CITY OF MARSHALL, MISSOURI FOR ELECTION OF CITY OFFICERS THEREIN.

WHEREAS, it is necessary and proper for the City of Marshall, Missouri (“City”), to hold regular elections in accordance with Missouri statutes and the City’s Code of Ordinances; and

WHEREAS, the City Clerk as the City’s Election Official, is required by law to propose an ordinance calling for a municipal election.

BE IT ORDAINED by the Council of the City of Marshall, Missouri as follows:

Section 1. An election is hereby called to be held on April 4, 2023, to elect the following officers of the City:

- a. Mayor for a 4- year term;
- b. First Ward Council Member for a 2-year term;
- c. Second Ward Council Member for a 2-year term;
- d. Third Ward Council Member for a 2-year term; and
- e. Fourth Ward Council Member for a 2-year term

Section 2. Any person duly qualified who desires to file for these positions at said election shall file with the City Clerk of the City of Marshall, Missouri, at any time after 8:00 a.m. on December 6, 2022, and before 5:00 p.m. on December 27, 2022.

Section 3. The City Clerk is hereby authorized and directed to publish notice of said election as required by law, send this Ordinance to the County Clerk of Saline County, Missouri, along with a sample ballot and a Notice of Election. Said Notice of Election shall be submitted to the County Clerk of Saline County, Missouri, no later than 5:00 p.m. on January 24, 2023.

Section 4. The polling places shall be set by the County Clerk of Saline County, Missouri, and shall be open for such times as required by applicable law.

Section 5. In all other respects, the Code of Ordinances of the City of Marshall shall be and remain unchanged.

Section 6. This Ordinance shall be in full force and effect from and after the date of its passage and approval and shall remain in effect until amended or repealed by the City Council.

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF MARSHALL, MISSOURI, TO EXECUTE A CONTRACT WITH MUNICIPAL PIPE TOOL COMPANY, LLC

BE IT ORDAINED by the Council of the City of Marshall, Missouri, as follows:

Section 1.
