AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF MARSHALL, MISSOURI, TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF MARSHALL AND PAUL MARTIN LAW LLC, FOR THE PROVISION OF LEGAL SERVICES.

BE IT ORDAINED by the Council of the City of Marshall, Missouri, as follows:

Section 1. The Mayor of the City of Marshall, Missouri, is hereby authorized to execute on behalf of said City an agreement with Paul Martin Law LLC, for the provision of legal services and consultation as requested by the City from time to time, and in consideration of the work completed under said agreement by Paul Martin Law LLC, the City shall pay Paul Martin Law LLC such rates and sums as are specified in the agreement, at such time or times as required by the agreement.

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF MARSHALL, MISSOURI TO EXECUTE A CONTRACT BETWEEN THE CITY OF MARSHALL AND THE MARSHALL-SALINE DEVELOPMENT CORPORATION.

BE IT ORDAINED by the Council of the City of Marshall, Missouri as follows:

Section 1. That the Mayor of the City of Marshall, Missouri, is hereby authorized and directed to execute on behalf of said City a certain contract between the City of Marshall and the Marshall-Saline Development Corporation for the provision of economic development services for the contract price of Fifteen Thousand and 00/100ths Dollars (\$15,000.00).

AN ORDINANCE ESTABLISHING GUIDELINES FOR OFFICIALS INVOLVED IN THE ACTIVITIES OF THE CITY OF MARSHALL, MISSOURI.

WHEREAS, the City Council of the City of Marshall, Missouri, desires to establish certain guidelines for conduct for elected officials involved in the activities of the City.

BE IT ORDAINED by the Council of the City of Marshall, Missouri, as follows:

Section 1. No individual member of the City Council shall directly interfere with the conduct of any department or duties of employees subordinate to the City Administrator except at the express direction of the City Council pursuant to an authorized vote at a Council meeting or with the consent of the City Administrator. The word term “interfere,” as used in this Section, means any act which tends to countermand an order or direction of the City Administrator or any act which directs an employee to take any action not authorized by the City Administrator.

Section 2. That all ordinances and parts of ordinances inconsistent with the provisions hereof are hereby repealed.

Section 3. This Ordinance shall be in full force and effect upon final passage and approval.
