ORDINANCE NO. _____

AN ORDINANCE PROVIDING FOR A GENERAL MUNICIPAL ELECTION TO BE HELD ON APRIL 7, 2026, IN THE CITY OF MARSHALL, MISSOURI FOR ELECTION OF CITY OFFICERS THEREIN.

WHEREAS, it is necessary and proper for the City of Marshall, Missouri (“City”), to hold regular elections in accordance with Missouri statutes and the City’s Code of Ordinances; and

WHEREAS, the City Clerk as the City’s Election Official, is required by law to propose an ordinance calling for a municipal election.

BE IT ORDAINED by the Council of the City of Marshall, Missouri as follows:

Section 1. An election is hereby called to be held on April 7, 2026, to elect the following officers of the City:

- a. Mayor for a 4-year term;
- b. First Ward Council Member for a 2-year term;
- c. Second Ward Council Member for a 2-year term;
- d. Third Ward Council Member for a 2-year term; and
- e. Fourth Ward Council Member for a 2-year term.

Section 2. Any person duly qualified who desires to file for these positions at said election shall file with the City Clerk of the City of Marshall, Missouri, at any time after 8:00 a.m. on December 9, 2025, and before 5:00 p.m. on December 30, 2025.

Section 3. The City Clerk is hereby authorized and directed to publish notice of said election as required by law, send this Ordinance to the County Clerk of Saline County, Missouri, along with a sample ballot and a Notice of Election. Said Notice of Election shall be submitted to the County Clerk of Saline County, Missouri, no later than 5:00 p.m. on January 27, 2026.

Section 4. The polling places shall be set by the County Clerk of Saline County, Missouri, and shall be open for such times as required by applicable law.

Section 5. In all other respects, the Code of Ordinances of the City of Marshall shall be and remain unchanged.

Section 6. This Ordinance shall be in full force and effect from and after the date of its passage and approval and shall remain in effect until amended or repealed by the City Council.
