

**CITY COUNCIL MINUTES
SPECIAL SESSION
SEPTEMBER 30, 2025
11:45 A.M.**

The Marshall City Council met in Special Session at 11:45 a.m. on Tuesday, September 30, 2025, in the Council Chambers of the City Office Building, 214 N. Lafayette, Marshall, MO 65340, with the following members present: Mayor Craig Thompson; Council Members Jim Papreck, Jeremy Gibson, Carter Fawkes, Nathan Swisher, Dan Brandt and Harold Simmons; City Administrator JD Kehrman, City Counselor Elizabeth Bellamy and City Clerk Julie Lewis. Council Members Drew Green and John Allen excused absent.

Council Member Swisher made a motion, seconded by Brandt, to adopt the agenda as written. A voice vote was taken with all in attendance in favor; Green and Allen excused absent. Motion carried.

ORDINANCES

An ordinance entitled “AN ORDINANCE AMENDING BUDGET ORDINANCE NO. 8848 OF THE CITY OF MARSHALL, MISSOURI, AS SUBMITTED FOR SAID CITY OF MARSHALL, MISSOURI” was given its first reading by title only.

Council Member Simmons made a motion, seconded by Swisher, to take the ordinance to a second reading. A roll call vote was taken with Simmons, Papreck, Gibson, Fawkes, Swisher and Brandt voting aye; Green and Allen excused absent. Motion carried.

Ordinance No. 8900 entitled “AN ORDINANCE AMENDING BUDGET ORDINANCE NO. 8848 OF THE CITY OF MARSHALL, MISSOURI, AS SUBMITTED FOR SAID CITY OF MARSHALL, MISSOURI” was given its second reading by title only and put to its final passage and approval upon motion of Swisher, seconded by Simmons. A roll call vote was taken with Papreck, Gibson, Fawkes, Swisher, Brandt and Simmons voting aye; Green and Allen excused absent. The ordinance is thereupon declared passed and so endorsed by the President of the Council and approved by the Mayor.

An ordinance entitled “AN ORDINANCE MAKING THE APPROPRIATION FOR THE PAYMENT OF ACCOUNTS OUT OF THE DIFFERENT CITY FUNDS” was given its first reading by title only.

Council Member Simmons made a motion, seconded by Gibson, to take the ordinance to a second reading. A roll call vote was taken with Papreck, Gibson, Fawkes, Swisher, Brandt and Simmons voting aye; Allen and Green excused absent. Motion carried,

Ordinance No. 8901 entitled “AN ORDINANCE MAKING THE APPROPRIATION FOR THE PAYMENT OF ACCOUNTS OUT OF THE DIFFERENT CITY FUNDS” was given its second reading by title only and put to its final passage and approval upon motion of Simmons, seconded by Swisher. A roll call vote was taken with Gibson, Fawkes, Swisher, Brandt,

Simmons and Papreck voting aye; Allen and Green excused absent. The ordinance is thereupon declared passed and so endorsed by the President of the Council and approved by the Mayor.

OTHER COUNCIL BUSINESS

There being no other Council Business, Council Member Swisher made a motion, seconded by Simmons, to adjourn the meeting. A voice vote was taken with all in attendance in favor; Green and Allen excused absent. Motion carried and the meeting adjourned at 11:50 a.m.
