**AN ORDINANCE VACATING A CERTAIN TRACT OF LAND IN THE CITY OF MARSHALL, MISSOURI HEREINAFTER DESCRIBED, WHICH WAS PREVIOUSLY CONVEYED AND DEDICATED TO THE CITY FOR STREET PURPOSES AND RESERVING A UTILITY EASEMENT OVER A PORTION OF SAID TRACT.**

**BE IT ORDAINED** by the Marshall, Missouri City Council as follows:

Section 1. It is in the best interests of the City of Marshall, Missouri, that the portions of the streets, hereinafter described, be vacated, reserving utility easements over the described portion of said streets.

Section 2. The following portion of Grant Avenue is hereby vacated, subject to existing easement(s):

A TRACT OF LAND BEING A PROTION OF GRANT AVENUE, A 60 FOOT WIDE ROAD PLATTED AS PART OF SEARGEANT'S ADDITION AS FOUND IN PLAT BOOK B AT PAGE 25 IN THE OFFICE OF THE RECORDER OF DEEDS FOR SALINE COUNTY, MISSOURI AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHEAST CORNER OF BLOCK 7 IN SAID ADDITION, SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE ALONG THE EAST LINE OF SAID BLOCK 7 IN SAID ADDITION, N 0° 57' 10"W, 170.1' TO THE NORTHEAST CORNER OF BLOCK 7, THENCE , S 87° 52' 05"E, 35', THENCE S 0° 57' 10"E, 170.1', THENCE N 89° 57' 36" W, 35' TO THE POINT OF BEGINNING.

Section 3. That the City Clerk shall record a certified copy of this Ordinance in the Office of the Recorder of Deeds, Saline County, Missouri.
